
- a. Employee created/advocated for the new Department of Aviation

Legislative Process


How does an idea become law?

- 1. Identify Problem what are you trying to solve?
- 2. Find a solution have can we fix it?
- 3. Stakeholder engagement does everyone agree?
- 4. Drafting process formalize your fix in legislative text.
- 5. Find your legislative champion who is going to help get you this fix?
- **6. Bill introduction** your hard work made it into bill form!
- 7. Additional stakeholder briefings making sure everyone is up to speed.
- 8. Committee hearing should be a formality by this point.
- 9. Final passage you can see the light at the end of the tunnel!
- **10. Enactment** fruit of your labor.

- Creation of new Airport Land Development Zone tax credit program (ALDZ)






